## What to expect

- Mortgages & Loan Documents (original note)
- o Business Ownership Information; Buy Sell Agreements, etc.
- Insurance Policies (life, disability)
- o Employee Benefits Statements, Agreements, Booklets
- List of Other Family Assets (i.e., Minor Children's Assets)

We are located at 2220 Sedwick Road, Suite 202, Durham, NC 27713. Take exit I-40 East or I –40 West via Exit # 278 for Hwy 55. Turn right at the bottom of the ramp towards Apex.
